



ILLINOIS SCHOOL HEALTH REQUIREMENTS 2022-2023 SCHOOL YEAR

All students must have the following forms on file for attendance to school. If you haven't already done so, now is a great time to schedule any necessary health, immunization, eye, and dental appointments so that your child(ren) will be ready to attend school this fall!

Pre-Kindergarten:

- State of Illinois Certificate of Child Health Examination, with current Immunization Record
Due once every two years - Completed and signed by Physician within 1 year prior to first day of school.

Kindergarten:

- State of Illinois Certificate of Child Health Examination, with current Immunization Record
Due October 15, 2022 - Completed and signed by Physician within one year prior to first day of school.
- State of Illinois Eye Examination Report
Due October 15, 2022 - Completed and Signed by Optometrist or Physician (such as an Ophthalmologist) within one year prior to the first day of school.
- State of Illinois Proof of School Dental Examination Form
Due May 15, 2023 - Completed and signed by Dentist between November 15, 2022 and May 15, 2023.

1st Grade:

- No additional requirements if previous requirements are up-to-date.

2nd Grade:

- State of Illinois Proof of School Dental Examination Form
Due May 15, 2023 - Completed and signed by Dentist between November 15, 2022 and May 15, 2023.

3rd, 4th, and 5th Grade:

- No additional requirements if previous requirements are up-to-date.

6th Grade:

- State of Illinois Certificate of Child Health Examination, with current Immunization Record
Due October 15, 2022 - Completed and signed by Physician within one year prior to first day of school.
- State of Illinois Proof of School Dental Examination Form
Due May 15, 2023 - Completed and signed by Dentist between November 15, 2022 and May 15, 2023.

7th and 8th Grade:

- No additional requirements if previous requirements are up-to-date.

New Students enrolling in an Illinois School for the first time (regardless of grade level):

- State of Illinois Certificate of Child Health Examination, with current Immunization Record
Due within 30 days of enrollment - Completed and signed by Physician within one year prior to first day of school.
- State of Illinois Eye Examination Report
Due within 30 days of enrollment - Completed and Signed by Optometrist or Physician (such as an Ophthalmologist) within one year prior to the first day of school.

Please note: IESA/IHSA Sports Physical Forms may not be used as the required Child Health Exam Form.

Illinois Examination Forms:

This form must be completed (including Health History section), signed by the student’s parent/guardian and physician, and submitted by October 15, 2022.
- [State of Illinois Eye Examination Report](#)
This form must be completed, signed by the student’s parent/guardian and physician, and submitted by October 15, 2022.
- [Proof of School Dental Examination Form](#)
This form must be completed, signed by the student’s parent/guardian and dentist, and submitted by May 15, 2023.

Religious/Medical Exemption Form:

- [Illinois Certificate of Religious Exemption to Required Immunizations and/or Examinations Form](#)
This form must be completed, signed by the student’s parent/guardian and physician, and submitted by October 15, 2022.

Medication Authorization Form:

- [Student Medication Authorization Form](#)
This form must be completed, signed by the student's parent/guardian and physician, and submitted prior to any medications being given, including over-the-counter medications.

Important Due Dates:

October 15, 2022

- Child Health Examination Form or Religious/Medical Exemption Form
- Eye Examination Report or Religious/Medical Exemption Form

May 15, 2023

- Dental Examination Form or Religious/Medical Exemption Form

Late submittals will only be accepted after the respective due date if the student is unable to receive a vaccine due to not meeting the age requirement to receive the vaccine by the due date.
